REGISTRATION PAYMENT AMOUNT	International students are required to pay 4 week session tuition (\$895) together with other applicable fees, at the time of registration.
DISCOUNTED RATE	You can pay 3 months together (\$870 per month). In case of refund it will be issued based on the regular monthly tuition fee, not at the discounted rate paid by the student.
PAYMENT DEADLINE	Tuition is due by the 5 th day of each session. After this date a late fee of \$50 will be charged.
TRANSFER OR LEAVE NOTICE	_____ Students are requested to submit a written notice to CalCC, by the 5 th day of the next session, Initial (yellow form) informing us that they intend to transfer or to leave the school.

MINIMUM TERM OF REGISTRATION	<ul style="list-style-type: none"> Once an F-1 student is registered at CalCC he/she is academically recommended to complete minimum ONE FULL QUARTER of study. During this time they can still transfer to another program by following the school's policy and SEVIS regulations for transfer. Student's I-20 will reflect the start and end dates according to this term. A student who wants to transfer must maintain status by attending classes until the transfer release date. If an F-1 student decides to transfer in the middle of a term his/her start date of the transfer-in school has to be within 15 days.
